Sub: Special meeting for discussion on SPS to evacuate more power through 400kV D/C Rangpo-Siliguri line from 400 kV Rangpo S/s.--regarding

Sir,

You may be aware that a meeting was held in CEA on 05.07.2016 for Power Evacuation from Teesta-III generation project in Sikkim wherein it was decided that till a Special Protection Scheme (SPS) is installed at Rangpo the loading on 400kV D/C line from Rangpo-Siliguri shall be limited to 750 MW only. Further, it was proposed that in order to evacuate Power more than 750 MW for generation projects pooled at Rangpo, a SPS may be installed at Rangpo 400kV S/s.

As informed, Teesta–III project is in advanced stage of completion and first unit is likely to be ready for synchronization. Subsequently, it is planned to commission all six units (200MW each) by April, 2017

In 125th OCC meeting of ERPC held on 20.09.16 the issue was deliberated and it was decided that a special meeting may be convened for discussion on the desired SPS jointly with CEA, CTU, Powergrid, NLDC, ERLDC and ERPC.

In order to discuss the issue a special meeting was scheduled on 5th October, 2016.

But due to some unavoidable reasons, the meeting is now deferred to 14th October, 2016 (Friday) at 11:30 hrs at ERPC Conference Hall, Kolkata. For effective designing of the SPS, the deliberations will be held on the following points:

- 1. Progress of Rangpo Kishanganj 400 kV D/C line.
- 2. Progress of implementation of SPS at Teesta-III HEP in Sikkim.

- 3. Progress of bays by Sikkim for terminating Chuzachen HEP Rangpo 220kV D/C line.
- 4. Progress of implementation of the Dikchu Poolling Station (presently to be operated 132 kV), and Dikchu P.S.- Rangpo 220 kV D/C line (to be initially operated at 132 kV), being implemented by Sikkim.
- 5. Operationalization of LTA:- (i) Teesta-III HEP, and (ii) Dikchu, Chuzachen, Jorethang and Tashiding HEPs in Sikkim.
- 6. System Protection Scheme (SPS) for Rangpo Silliguri 400 kV D/C line.

You are requested to kindly note the revised date and attend the meeting.
