Sub: Preparation of Phasing out Plan for implementation of new Environmental Norms for Thermal Plants, issued by MOEF&CC -- reg

Sir,

As you may be aware that New Environmental Norms issued by MoEF&CC are required to be implemented w.e.f. 7th Dec 2017. Presently, there is about 72GW capacity of thermal units, which are not in a position to install FGDs due to non-availability of space in plant. As such these units would not be able to meet new SOx emission norms. Such thermal units are required to be phased out. In the recent meeting held between Secretary (P) and Secretary (MoEF&CC) on 14th March 2017, it was advised that CEA may prepare the plan for phasing out the aforesaid capacity and submit the same immediately. Subsequently, a meeting was held at CEA for discussion on this subject on 17.3.2017 and following were decided:

- 1. The list of 72 GW thermal capacity which is to be phased out was not received by some of the participants. The list of Eastern Region units is enclosed at **Annexure-I**.
- 2. RPC secretariat would call an urgent meeting with constituents on this issue and prepare a phasing out plant in consultation with all utilities including RLDCs. The difficulties if any in closing these units by December 2017 as mentioned by states would be clearly mentioned in the report to enable CEA to took up the issue with MoP and MoEF.
- 3. In the meeting it was decided that a meeting should be held within a week so that plan is forwarded to CEA by week end.
- 4. Chairperson, CEA also advised that POSOCO may prepare a report considering an extreme case scenario in respect of 2018-19 if 72 GW capacity is taken out in Dec,2017. In case of load generation balance data for 2018-19 is not available, any present day scenario can be used as representative case.
- 5. The phasing out plan should consider grid operation issues like grid security, transmission constraints and local problems like radial loads. The focus of the whole exercise should be technical like maintaining load generation balance and grid security aspects, as commercial aspect would be looked after by appropriate commission.

Therefore, it is requested that your plan for phasing out of such old units may be furnished to this office (e-mail: mserpc-power@nic.in) at the earliest.

Further, in order to prepare a plan for phasing out of the non-compliant thermal power plants keeping in view the power supply position in the region a special meeting is scheduled on 24.03.2017 (Friday) at 11:30 AM in ERPC, Kolkata.

You are requested to kindly participate or depute your concerned officer(s) in the meeting with all the relevant details.

Please consider this as most urgent.
