Please refer the special meeting held on 14.10.2016 & 30.11.2016 at ERPC, Kolkata for discussion on installation of SPS at 400kV level at Rangpo S/s for reliable power evacuation through 400kV Rangpo – Siliguri D/c line. In this regard it is to inform that Teesta-III HEP has declared COD of all six units (6x200 MW) in February, 2017. In the special meeting of 30.11.16, it was agreed that the power flow through Rangpo – Siliguri D/C line would be reviewed periodically and depending upon the requirement of additional power flow, the limit of the maximum power flow on the line would be enhanced progressively.
