Eastern Regional Power Committee (ERPC), Kolkata, West Bengal, invites bids in two bid system for tenders for supply & Installation of Gym Equipment's at ERPC office. Bidders are requested to quote their best offer along with the complete details of specifications, terms & conditions. The details of requirement & Specifications are at Annexure-I, II.

Executive Engineer (TS&C)

Section A: Instructions for the Contractor/Bidders:

- 1. Purchaser shall mean Eastern Regional Power Committee (ERPC). Supplier shall mean the bidder who has been selected through the tender process to supply the goods as per NIT.2. Bids shall be submitted physical only at ERPC office. Bids will be under three packet system with
- separate packets for EMD, Technical Bid and Price Bid.
- 3. Contractor/Bidders are advised to follow the instructions provided in the 'Instructions to the Contractors/Bidders for the submission of the bids.
- 4. Partial bids will not be accepted.
- 5. EMD Payment: The bidder shall be required to submit the Earnest Money Deposit (EMD) for an amount of Rs. 10,374/- (Rupees Ten Thousand Three Hundred Seventy Four Only) by way of demand drafts only. The demand drafts shall be drawn in favour of "ERPC Establishment Fund". The EMD of the successful bidder shall be returned after the successful submission of Performance Bank Guarantee/ Security Deposit and for unsuccessful bidder(s) it would be returned after award of the contract. The demand drafts for EMD must be put in a separate envelope marked "EMD".
 - a) Bidder shall not be permitted to withdraw his offer or modify the terms and conditions thereof. In case the bidder fail to observe and comply with stipulation made herein or backs out after quoting the rates, the aforesaid amount of earnest money will be forfeited.
 - b) The Firm who are registered with National Small Industries Corporation (NSIC) / OR Small Scale Industries (SSI) are exempted to submit the EMD (Copy of registration must be provide in the EMD packet)
 - The EMD, in case of unsuccessful Bidders shall be retained by ERPC, Kolkata till the **c**) finalization of the tender. No interest will be payable by ERPC on the EMD.
- 6. Bids without EMD will be summarily rejected.
- 7. Submission of Tender: The tender shall be submitted in three part, viz., EMD, technical bid and price bid. All the pages of bid being submitted must be signed and sequentially numbered by the bidder irrespective of nature of content of the documents.
- 8. Offers submitted by Telegram/Fax/email shall not be considered. No correspondence will be entertained in this matter.

Section B: Preparation and submission of Bids

I. Technical Bid

The following documents are to be furnished by the bidder along with Technical Bidas per the tender document:

- a) Duly filled format of Technical Bid as per Annexure III.
- b) Copy of constitution or legal status of the bidder manufacturer / Sole proprietorship / firm / agency etc.
- c) Certificate of Manufacture or Authorized Distributor.
- d) Quality Assurance Certification for manufacturer: ISO 9000/9001/9002 or equivalent to be submitted
- e) Copy of PAN Card.
- f) Copy of GST registration certificate, if applicable.
- g) Duly Signed Tender document and their annexure.
- h) All other document mentioned in tender document.
- i) The Demand Draft of EMD should be prepared in favour of "ERPC Establishment Fund" payable at Kolkata.
- i) Undertaking in format Annexure-IV must be submitted.

Mandatory Qualifying Criteria

- a) Bidder must have supplied against one supply order fitness equipment, sports goods, sports accessories, etc valued at least 4 lakhs OR against two supply orders for at least 3 lakhs each OR at least three Supply orders valued at least 2 Lakhs each in the last five years. (Documentary proof like supply order, payment details, completion certificate to be submitted).
- b) Bidder must have a turnover of at least 10 Lakhs for last three completed financial years.(Documentary proof such as audited Profit and Loss A/c must be enclosed)
- c) Experience Certificate of supplying Gym equipment to a Government department, PSU and Banks in the past Three years.
- d) Catalog, brochure, Technical Data, Specifications and Model No of the equipment proposed must be submitted with the Technical bid
- e) The bidder must have a sales/service office in Kolkata

Failure to meet the mandatory qualifying criteria will lead to bid as unresponsive.

II. Price Bid

Price bid Form [As per Annexure-V duly filled and signed] - Price must be quoted as per format specified; failing which tender shall be summarily rejected. All prices should be inclusive of taxes, duties, levies and delivery charges costs.

III. Procedure

At first, the EMD envelope would be opened. If EMD are found in order then the Technical bid will be opened. If Technical bid is found in order then price bid for technically qualified bidders would be opened and L1 bidder will be selected.

Section: C General Term & Conditions

- 1. "PRE BID Meeting" with the intending bidders shall be held on 31st August, 2017 at 12:00 P.M. onwards at Conference Hall, ERPC Kolkata. All the prospective bidders are requested to send comments/ representations on or before pre-bid meeting.
- 2. Validity: The quoted rates must be valid for a period for 60 days from the date of closing of the tender. The overall offer for the assignment and bidder(s) quoted price shall remain unchanged during the period of validity. If the bidder quoted the validity shorter than the required period, the same will be treated as unresponsive and it may be rejected.

In case the bidder withdraws, modifies or changes his offer during the validity period, bid is liable to be rejected and the earnest money deposit shall be forfeited without assigning any reason thereof.

- 3. Technical Evaluation:
 - (a) Detailed technical evaluation shall be carried out by ERPC pursuant to conditions in the tender document to determine the substantial responsiveness of each tender. For this clause, the substantially responsive bid is one that conforms to all the eligibility, mandatory qualifying criteria and terms and condition of the tender without any deviation. ERPC's determination of bid's responsiveness is to be based on the contents of the bid itself without recourse to extrinsic evidence. ERPC shall evaluate the technical bids also to determine whether they are complete, whether required sureties have been furnished, whether the documents have been properly signed and whether the bids are in order.
 - (b) ERPC Kolkata shall have right to accept or reject any or all tenders without assigning any reasons thereof.

4. Financial Evaluation:

- (a) The financial bid shall be opened of only those bidders who have been found to be technically eligible. The financial bids shall be opened in presence of representatives of technically eligible bidders, who may like to be present. ERPC shall inform the date, place and time for opening of financial bid.
- (b) Arithmetical errors shall be rectified on the following basis. If there is a discrepancy between the unit price and total price that is, the lower impact price shall prevail and the total price shall be corrected by the ERPC. If there is a discrepancy between words and figures, the lesser amount shall be considered as valid. If the Supplier does not accept the correction of the errors, his bid shall be rejected.
- (c) After due evaluation of the bid(s) ERPC, Kolkata will award the contract to the lowest evaluated responsive bidder. Conditional bid will be treated as unresponsive and will be rejected.
- 5. Award of Contract: ERPC shall consider placement of orders for jobs on those bidders whose offers have been found technical and financially acceptable.
- 6. Security Deposit: The successful bidder will be required to furnish a Performance Security Depositof 10% of order value in the form of Fixed Deposit Receipt or Bank Guarantee from any Nationalized Bank duly pledged in the name of the "ERPC Establishment Fund" after receipt of supply order for a period of 60 days after end of warranty period.

The security deposit can be forfeited by order of this ERPC in the event of any breach or negligence or non-observance of any condition of contract or for unsatisfactory performance or non-observance of any condition of contract. Security deposit will be discharged after completion of all the contractual obligations. The Security Deposit amount will not carry any interest.

- 7. Demonstration: The bidders may be asked to demonstrate the product as and when required by ERPC failing which their bids/offer shall be rejected. Failure to demonstrate, offer will be summarily rejected. The expenditure incurred for demonstrating the items will be borne by the supplier, no Claim in this regard will be entertained.
- 8. Rate: Prices quoted for individual items should be inclusive of all taxes and duties including, Customs Duty, Excise Duty, GST, etc. It should also include packing, forwarding, transport, insurance, loading/ unloading, installation, etc. Rate should be quoted only in Indian Rupees (INR) inclusive of all the Charges.
- 9. Manufacture authorization Certificate: The bid must be submitted by manufacturer or authorized distributor. The bidders are required to provide manufacturer's authorization certificate on company's letterhead along with the technical bid.
- 10. Warranty / Guarantee:

The Bidders must quote for 1 (One) year comprehensive on-site warranty (Including all Spares, Accessories and Labour) from the date of completion of the satisfactory installation. The warranty charges shall not be quoted separately otherwise the offer shall be summarily rejected. Failure to comply this condition will entail the rejection of the bids.

No offer of the vendor will be accepted without warranty/ guarantee of their supplied/ installed goods.

The bidders are required to submit a certificate that they have satisfactory service arrangements and fully trained staff available to undertake repair and maintenance.

11. Authority of person signing document: A person signing the tender form or any documents forming part of the contract on behalf of another shall be deemed to warranty, that he has authority to bind

such other and if, on enquiry, it appears that the person so, signing had no authority to do so, the ERPC, Kolkata may without prejudice to other Civil and criminal remedies cancel contract and held the signatory liable for all cost and damages.

12. Delivery and Installation: The items shall be delivered and successful installed/ commissioned within 30 days from the issue of supply order at ERPC premises. The successful bidder will also provide required training free of cost for supplied items at ERPC Kolkata.

All the aspects of safe delivery, installation and commissioning shall be the exclusive responsibility of the supplier. If the supplier fails to deliver, install and commission the goods on or before the stipulated date, then a penalty at the rate of 0.5% per week of the total order value shall be levied subject to maximum of 10% of the total order value.

If at any time during the currency of the contract, the supplier encounters conditions hindering timely delivery of the goods and performance of services, the supplier shall promptly inform the ERPC for extension of the delivery schedule accordingly. On receiving the supplier's communication, ERPC shall examine the situation as soon as possible and, at its discretion, may agree to extend the delivery schedule, with or without liquidated damages for completion of supplier's contractual obligations by issuing an amendment to the contract.

In the case of package supply where the delayed portion of supply materially hampers installation and commissioning of the systems, liquidated damages charges shall be levied as above on the total value of the concerned package of the purchase order. Quantum of liquidated damages assessed and levied by the purchaser shall be final and not challengeable by the supplier.

- 13. Right of acceptance: The ERPC Kolkata reserve the right to reject any or all bids /quotations or all offers received in response to the tender or cancel or withdraw the tender notice without assigning any reason thereof and also does not bind itself to accept the lowest quotation or any tender and no claim in this regard shall be entertained.
- 14. Inspection:
- (a) ERPC, Kolkata shall have the right to inspect and/or to test the goods to confirm their conformity to the NIT Specifications at no extra cost to the Purchaser.
- (b) ERPC, Kolkata right to inspect, test and, where necessary, reject the Goods after the goods arrival at the final destination shall in no way be limited or waived by reason of the Goods having previously been inspected, tested and passed by ERPC, Kolkata prior to the goods shipment.
- (c) Member Secretary, ERPC Kolkata shall be the final authority to reject full or any part of the supply which is not confirming to the specification and other terms and conditions.
- (d) No payment shall be made for rejected Stores. Rejected items must be removed by the Bidders within two weeks of the date of rejection at their own cost and replaced immediately. In case these are not removed, these will be auctioned at the risk and responsibility of the suppliers without any further notice.
- 15. Payment Term: The Bill in triplicate may be sent to this office for settlement after satisfactorily delivery & installation/ commissioning of the material. The bill should have full particulars of the items. No Payment shall be made in advance nor shall the loan from any or financial institutions be recommended on the basis of the order of award of work. The Contractor shall submit the bill only after supply & installation/ commissioning of the material to the satisfaction of the ERPC Kolkata. The case of issuing sanction and passing of bill for payment will be initiated on receipt of a

pre-receipted invoice from the Contractor. No payment will be made for goods rejected.

- 16. Specification: Bids which are not meeting the bid specifications are not permitted and will be rejected.
- 17. Quality Assurance Certification for manufacturer: ISO 9000/9001/9002 or equivalent is essential.
- 18. Arbitration: If any difference arises concerning this agreement, its interpretation or payment to be made there-under, the same shall be settled as per the provision of Arbitration and Conciliation Act, 1996 and the rule framed there under and in force shall be applicable to such proceedings.
- 19. Breach of Terms and Conditions: In Case of breach of any terms and conditions as mentioned above, the Competent Authority, will have the right to reject the bid at any stage without assigning any reason thereof and nothing will be payable by ERPC, Kolkata in that event the EMD shall also stands forfeited.
- 20. Subletting of Work: The firm shall not assign or sublet the work/job or any part of it to any other person or party without having first obtained permission in writing of ERPC, Kolkata, which will be at liberty to refuse if thinks fit. The tender is not transferable. Only one tender shall be submitted by one bidder.
- 21. Insolvency etc: In the event of the firm being adjudged insolvent or having receiver appointed for it by a court or any other order under the Insolvency Act made against them or in the case of a company the passing any resolution or making of any order for winding up, whether voluntary or otherwise, or in the event of the firm failing to comply with any of the conditions herein specified, ERPC Kolkata shall have the power to terminate the contract without any prior notice.

ERPC reserves the right to reject the quotations of the bidders whose quotation were not found of quality required by ERPC, Kolkata. If necessary, ERPC reserves the right to accept/ reject any quotation either in part or full without assigning any reason thereof.

- 22. The items will have to be supplied at ERPC, Kolkata. No transportation/ cartage charges will be provided for the same.
- 23. Bidder shall submit a copy of the tender document and addendum/corrigendum thereto, if any, with each page of this document should be signed and stamped to confirm the acceptance of the entire terms & conditions as mentioned in the tender enquiry document.
- 24. ERPC reserves the right to accept in part or in full or reject any or more tender(s) without assigning any reasons or cancel the tendering process and reject all tender(s) at any time prior to award of contract, without incurring any liability, whatsoever to the affected bidder or bidder(s).
- 25. Applicable Law:
 - The contract shall be governed by laws and procedures established by Govt. of India, within the framework of applicable legislation and enactment made from time to time concerning such commercial dealings/ processing.
- Any disputes are subject to exclusive jurisdiction of competent court and forum in Kolkata, West Bengal, India only
- 26. Force Majeure: Any delay due to Force Majeure certified by the purchaser will not be attributable to the supplier.
