Minutes of Special Meeting on implementation of CERC order on KBUNL held on 23.03.18 at ERPC Kolkata.

List of the participants is given in Annex-I

MS, ERPC welcomed the participants in the meeting. He informed that the meeting has been convened to finalize the methodology of implementation of CERC order dated 09.03.2018 wrt to petition no 20/MP/2017 in the matter of KBUNL vs CTU and others.

MS, ERPC informed that the following issues need to be deliberated:

1. Operationalization of LTAs of the beneficiaries of MTPS St-II
2. Scheduling of MTPS St-II power
3. Metering arrangement for accounting the transaction

Detailed deliberation took place on the above issues. The following decisions were arrived at:

1. Operationalization of LTAs of the beneficiaries of MTPS St-II
Sh Ashok Pal, GM, CTU informed over telephone that the LTAs of the beneficiaries of MTPS St-II would be operationalized wef 01.04.2018.
2. Scheduling of MTPS St-II power
 - MTPS St-II will give DC to ERLDC on day ahead basis. Based on this ERLDC will give the entitlement of the beneficiaries of MTPS St-II.
 - Based on the requisition of power received from the beneficiaries schedule of MTPS St-II shall be finalized by ERLDC.
 - If no requisition is received from any beneficiary constituent, ERLDC shall treat it as zero requisition for the purpose of scheduling.
 - ERPC will recirculate the order regarding 100% allocation of MTPS St-II.
 - For the purpose of scheduling, no ISTStranmission losses shall be applicable for the component of power scheduled for Bihar. For other beneficiaries existing regulations regarding PoC charges and losses shall be applicable.
 - However, all the beneficiaries shall pay the ERLDC charges.

3. Metering arrangement for accounting the transaction

PowerGrid, ER-I, Patna confirmed over telephone that the requisite number of meters have been made available to MTPS.

It was decided that metering arrangement shall be done in such a way that the actual generation of MTPS St-II can be computed and the actual injection of power to CTU network from MTPS bus can be determined. The difference between the actual generation of MTPS St-II and injection to CTU network shall be considered as drawl by Bihar from MTPS St-II for the purpose of DSM calculation of Bihar.
