
You may be aware that, in the referred meeting, the issue of Strengthening of the 220 kV Tenughat-Biharshariff line was deliberated and JUSNL and BSPTCL were advised to do survey of their respective portion of the line and assess the requirements like ground clearance, sag etc for charging the line at 400kV level. Further, it was emphasized that a report on the assessment may be submitted by March 2018. Also, in 37th TCC meeting held on 16th March, 2018, TCC advised ERPC Secretariat to convene a separate meeting after completion of the survey for deciding the next course of action.

Therefore you are requested to submit the report on the assessment for strengthening of 220 kV Tenughat-Biharshariff line by 25th April, 2018 to this office. Further, in line with the decision of 37th TCC meeting a **special meeting to finalize the course of action for charging of 220kV Biharsharif-Tenughat line at 400 kV level will be held on 3rd May, 2018 (Thursday) at 11:00 hrs at ERPC Conference Hall, Kolkata.**
