Sub: Special Meeting on 13.12.2018 at 11:00 Hrs at ERPC Kolkata in connection with Repeated interruption of Power Supply from Lalmatia 220/132 kV S/ Stn. of ECL due to uncoordinated trippings vis-à-vis implementation of Protection Audit Report - regarding

The issue regarding uncoordinated trippings from Lalmatia 220 / 132 kV S/stn (owned by M/s ECL) had been discussed in the recently concluded 39th TCC / ERPC meeting held on 16/17.11.2018 at Jaipur. NTPC highlighted that many of the equipment at Lalmatia S/stn (commissioned during 1989) are very old, obsolete and have outlived their utility. They needed immediate replacement to implement the observations of Protection Audit done by ERPC team on 16.08.2018. It has been requested that in spite of various correspondences from NTPC in this respect, prompt reply from ECL is not forthcoming. As a result, Power Supply from Lalmatia S/stn have been interrupting suffering both the consumers of JUSNL and ECL mines.

Taking into consideration the need to refurbish the asset of 220 kV Farakka- Lalmatia System immediately to mitigate the repeated trippings & grid security, ERPC in its 39th meeting, advised Member Secretary to convene a meeting among NTPC, ECL and JUSNL to discuss the issue of up gradation of Lalmatia S/ stn.

Accordingly, a meeting has been convened on 13.12.2018 (Thursday) at 11:00 Hrs. to discuss the above issue.

It is therefore requested to kindly make it convenient to attend the meeting on 13.12.2018 (Thursday) at 11:00 Hrs.
