AGENDA FOR THE MEETING ON AUGMENTATION OF COAL SUPPLY AND ITS TRANSPORTATION TO VARIOUS POWER STATIONS IN EASTERN REGION BEFORE PUJA FESTIVAL,2019

Date: 18th September' 2019, Time: 11:00 Hrs. Venue: ERPC, Conference Hall, Kolkata

Background: It has been observed that at present, NTPC stations in the Eastern Region i.e. KhSTPS, TTPS, TSTPS, and some of the power stations of WBPDCL and DVC have super critical coal stock. The issues were also deliberated in the recent meeting taken by the Hon'ble Minister I/C, Power, Government of West Bengal on 20.08.2019 at Kolkata to ensure uninterrupted supply of power during the festival seasons. During the meeting, it was suggested that ERPC should hold a separate meeting in the second week of September, 2019 among the Coal companies, Railways, Power Station Authorities, SLDCs and ERLDC. In view of above, it is decided to review the status of coal stock at different power stations in the Eastern Region and initiate corrective actions, if any, required in this regard.

## ITEM NO.1: COAL STOCK POSITION AS ON 15.09.2019

As per the CEA report, coal stock position at the power stations of NTPC at KhSTPS, TTPS, Talcher STPS and DVC power stations at Mejia TPS& Durgapur Steel TPS are super critical coal stocks. The power stations at Kolaghat TPS of WBPDCL and HEL have also super critical stock (less than 4 days stock) The details are given at Annexure-I.

NTPC, DVC & WBPDCL may give presentations separately highlighting the issues associated with supply of coal and action plan drawn for improvement to their power stations.

The issues highlighted by the concern utilities may please be discussed.
