You may be kindly aware that OPGC Ltd. has connected its U#4 (660MW) to the STU network of Odisha by closing the bus sectionalizer breakers between bus 1A & 2A and 1B & 2B at 11.07hrs and 11.17hrs respectively on 27.08.2019 and accordingly scheduling of the same has commenced by SLDC Odisha.

ERLDC, vide letter no. ERLDC/SO/2019-20/2191 dated 29.08.2019, has observed violation of grid discipline and IEGC by SLDC Odisha and OPGC due to the action taken by them on 27.08.2019 and has requested ERPC Secretariat for convening a special meeting to discuss the issue.
