With reference to the above, it is informed that NTPC and Assam (APDCL) have entered in to a supplementary contract for sale-purchase of 25 MW power from Farakka Stage –III from 00.00 hrs of 19.10.2019 to 24.00 hrs of 30.11.2019. This 25 MW is presently with NTPC for sale outside long term PPA.

Dear Sir,

Ministry of Power, Govt. of India vide letters dated 09.12.2010 has allocated 75 MW from Farakka STPS Stage-III for sale outside long term PPA out of which 50 MW is already being supplied to Jharkhand.

In this regard, Assam (APDCL) is willing to avail balance 25 MW power from FSTPS Stage -III (copy of letter dtd 17.10.2019 attached) out of the above mentioned 75 MW from 00:00 hrs of 19.10.2019 to 24:00 hrs of 30.11.2019, at CERC approved tariff. The terms of power supply will be in line with the existing PPA of APDCL with NTPC dtd 24.06.2011 for supply of power from NTPC stations including FSTPS-III.

Therefore, it is requested that the allocation of FSTPS stage - III (500 MW) may kindly be revised considering 25 MW power allocation to Assam (APDCL) and the above may be taken into account for scheduling/ preparing REA for FSTPS Stage - III w.e.f. 00:00 hrs of 19.10.2019.
