- 1. The power transfer throgh ICT 400/132 kV at Mangdechhu pot head yard has been adjusted as per the provisions of the PPA signed between PTC & DGPC.RGoB on 15th Aug.2019.
- 2 . As per the Minutes of Meeting held on 13.07.2018 " Bhutan representative informed that Mangdechhu units are expected to be commissioned by April,2019. Bhutan assured that, with the commissioning of Mangdechhu units, cases of net import of power by Bhutan in a month shall not occur." Accordingly, import of power by Bhutan during 2019 was treated as a special case and was adjusted against cheapest source (i.e TALA).
- 3. As per the Minutes of Meeting held on 17.05.2019 at ERPC, Kolkata "It was clarified by Bhutan representative present in the meeting that the internal load of Bhutan shall be met from cheapest sourse of power in the ascending order. Thereafter, surplus power, if any, shall be exported to india"
- 4. It is being observed that there is import of power by Bhutan in the month of January 2020 as well. Hence, based on the above MoMs, from now onwards, any net import of power by Bhutan shall be adjusted against the cheapest source of Bhutan hydro stations in the ascending order of its exportable tariff. In the month of January 2020, the net import of energy by Bhutan is 13.127645MU. Accordingly, this was adjusted against the entire Tala generation of 9.868327MU during January 2020. However, the remaining 3.259318MU was inadvertently not adjusted against the next cheaper source (as per the ascending order) i.e Chukha. The same adjustment has been done in this revised account.
