Statement of Deviation charges for the week has been prepared as per CERC(DSM & Related matters) regulation,2014 & all amendments(**including 5<sup>th</sup> Amendment regulation,2019 dated 28.05.2019**)

RRAS Settlement Account for the weeks has been prepared as per the guidelines of Detailed Procedure for Ancillary Services Operation approved by CERC. AGC Settlement Account for the week has been prepared based on the CERC order in petition No. 79/RC/2017, dated 06.12.2017.

*The last installment of data for the subjected week has been received from ERLDC on 16.10.2020.*

The constituents, who have to pay the Deviation Charges as indicated in the statement, are requested to make the payment to the Deviation Pool account operated by ERLDC within 10 days of the billing date. In case of delayed payments for Deviation charges against these bills beyond 12 days, the defaulting constituents shall have to pay simple interest @0.04 % for each day of delay.

- b) **Western Region :** Ranchi end of Ranchi-Dharamjaygarh 765kV D/C, ER end of Sundergarh-Dharamjaygarh 765kV D/C,  
ER end of Sundergarh-Raigarh 400kV Q/C, ER end of Ranchi-Sipat 400kV D/C, Budipadar-Korba 220 kV lines & Budhipadar-Raigarh 220kV D/C Lines
- c) **Southern Region:** Angul end of Angul-Sirkakulam 765kVD/C Lines, Jeypore end of Jeypore -Gajuwaka D/C & East bus of TSTPP Stage I & II interconnector.
- d) **North Eastern Region:** NER end of 220 kV Alipurduar -Salakati D/C ,400 kV Alipurduar Bongaigaon and 400kV Binaguri - Bongaigaon D/C lines.

ii) For computing Deviation Charge for the week , Korba meter(NP2657A) has been used as master frequency meter.

iii) Deviation charges for the week has been calculated as per amendment of CERC ( Deviation Settlement Mechanism and related matters) Regulation.Notification no. No.L-1/132/2013/ CERC dated 06.01.14. Amendment as per CERC order dated 20.01.2015 on petition no RP/06/2015, 4th Amendment order dated 20.11.2018 and 5th Amendment order dated 28.05.2019 have also been incorporated.

iv) ACP values for computation of deviation rate vector has been taken from NLDC website

v) The Cap rate for all generators has been fixed at 303.04 paisa/kwh as per DSM 5th amendment'2019.

vii) Additional Deviation Charge due to violation of Block wise volume limit is inclusive of Additional deviation charge due to OD/UI at  $f < 49.85\text{Hz}$  & OI/UD at  $f \geq 50.10\text{Hz}$ .

vii) CHPC, KHPC, THPC and Mangdechhu are not covered under ABT. Hence Deviation energy (MWh) of these stations shall be adjusted monthly after getting data from concerned agency.

viii) The payable/receivable of "Deviation Charge " in respect of Inter-Regional exchanges are settled on first charge basis without any adjustment.

ix) As informed by ERLDC OPGC (2\*660 MW), new Pool Member of ER, has started drawing power from 15.01.18.

x) As informed by ERLDC NPGC(NTPC) became a regional entity and DSM pool member wef 10.05.18 as NPGC started drawing start up power wef 10.05.18

xi) As informed by ERLDC DARLIPALI(NTPC) became a regional entity and DSM pool member wef 31.05.18.

xii) Dagachhu HEP has been considered as pure Run of River without pondage as per TPTCL letter dated 06.02.2019 for computation of ADC due to sign change violation
