Statement of Deviation charges for the week has been prepared as per CERC (DSM & Related matters) regulation,2014 & all amendments (including 5th Amendment regulation,2019 dated 28.05.2019) & **Petition No. 11/SM/2020 dated 29.05.2020.**

RRAS Settlement Account for the weeks has been prepared as per the guidelines of Detailed Procedure for Ancillary Services Operation approved by CERC. AGC Settlement Account for the week has been prepared based on the CERC order in petition No. 79/RC/2017, dated 06.12.2017.

The last installment of data for the subjected week has been received from ERLDC/NLDC on 29.10.2021.

The constituents, who have to pay the Deviation Charges as indicated in the statement, are requested to make the payment to the Deviation Pool account operated by ERLDC within 10 days of the billing date. In case of delayed payments for Deviation charges against these bills beyond 12 days, the defaulting constituents shall have to pay simple interest @0.04 % for each day of delay.

Amendment as per CERC order dated 20.01.2015 on petition no RP/06/2015, 4th Amendment order dated 20.11.2018, 5th Amendment order dated 28.05.2019 & clause 7.10(b) of DSM 5th Amendment has been incorporated we.f. 01.12.2020.**
- iii) ACP values for computation of deviation rate vector has been taken from NLDC website
- iv) The Cap rate for all generators has been fixed at 303.04 paisa/kwh as per DSM 5th amendment 2019.
- v) Additional Deviation Charge due to violation of Block wise volume limit is inclusive of Additional deviation charge due to OD/UI at $f < 49.85\text{Hz}$ & OI/UD at $f > 50.10\text{Hz}$.
- vi) CHPC, KHPC, THPC and Mangdechhu are not covered under ABT. Hence Deviation energy (MWh) of these stations shall be adjusted monthly after getting data from concerned agency.
