

Subject:- Re-allocation of 209 MW Power to Government of Punjab out of surrendered share of various States/UTs allocated from the Power Stations of NTPC.-reg.

Sir,

Government of Punjab have requested to extend the allocation of power earlier allocated up to 20.12.2021 vide this Ministry's letter dated 06.12.2021 beyond 20.12.2021 up to the extent of 209 MW for a further period of one month i.e. up to 20.01.2021. Keeping in view the power surrendered by beneficiaries of various Power Stations of NTPC and the willingness of Government of Punjab to extend the allocation of power up to 20.01.2022 already made to the State till 20.12.2021, it has been decided to re-allocate 209 MW Power to Punjab from the Power Stations of NTPC given below along with the quantum up to 20.01.2022 as per the tariff determined by CERC from time to time in continuation to this office order of even no. dated 06.12.2021.
