Minutes of Special Meeting held on 14.06.2022(Tuesday) at 10:30 AM on extension of SCADA/EMS contract from 2023 to 2025 as per rated terms and conditions Issues related to M/S Chemtrols

List of participants is attached in **Annexure-A**

SE(Commercial), ERPC chaired the meeting and at the outset, he briefly explained the issue.

Further, he requested M/S Chemtrols representative to submit their concern.

M/S Chemtrols representative submitted that it would be better to approach different constituents individually and extend the contract as per their individual requirement. He also expressed that as per the contract, only RTU integration work is included under scope of work, however, as per request of different constituents, RTU maintenance work was also done by Chemtrols causing them huge financial implication. On query regarding cost escalation for the extension of contract, he requested all constituents to increase the overall maintenance cost of each control center by approx. 35 % (excluding the RTU Maintenance)

Powergrid representative informed that as per original contract with M/S Chemtrols, it is clearly mentioned that employer may extend contract for 2 years as per the same rate and terms & conditions. Accordingly, constituents may extend the contract individually with M/s Chemtrols.

SE(Commercial), ERPC submitted that M/s Chemtrols is ought to abide by the terms and conditions of the contract. However, he proposed the following:

- a) Extension of contract may be done at same rate and conditions. Since RTU maintenance was not included in the scope of work of original contract, M/s Chemtrols may submit separate cost estimate for maintenance of RTUs. If all the constituents agree with the cost proposal, then separate contract would be signed for RTU maintenance.
- b) Extension of contract may be done at a revised incremented cost for all control centers including RTU maintenance.

M/S Chemtrols agreed to submit the cost estimation for the said proposals to ERPC within one week.

M/s Chemtrols requested that the RTU maintenance charges be in effect from 1st July, 2022.

All the concerned utilities' representatives agreed with first proposal that extension of contract may be done at same rate and conditions and separate constituent wise contract may be signed for maintenance of RTUs if constituents agree with maintenance cost. Powergrid advised for the same.

Further, M/S Chemtrols requested the constituents to reduce the bank guarantee which may be issued against the AMC cost of the extended contract only. M/s Chemtrols was advised to reduce the bank guarantee to 3% value (as per Govt. norms) against AMC cost only for the extended contract at the time of extension of the Contract.

M/S Chemtrols representative requested the concerned constituents to release the 10% amount of total cost that was withheld by the constituents at time of commencement of the contract. Constituents agreed to release 5 % amount of total cost withheld by them against bank guarantee of same cost to be provided by M/S Chemtrols.

SE(Commercial), ERPC informed that after receipt of cost for both proposals by M/S Chemtrols, a special meeting would be convened among all the concerned constituents to resolve this issue.









