Please refer to the issuance of Provisional Regional Energy Account (REA) for the month of January' 16 issued vide this office letter No.ERPC/COM-I/REA/2015/H3791-H3830 dated 02.02.2016 excepting REA for Chukha HPS, Kurichhu HPS, Tala HPS (Page No-11/11).

Upon receipt of meter reading data for the respective Hydro Stations from PTC, the REA for January' 16 in respect of Chukha HPS and Tala HPS is hereby prepared and issued.

It is observed that for the month, Bhutan, through Kurichhu System has imported power from Indian system of the tune of approximately 16,068 MWH. The same has been adjusted from Tala HPS.

Please find enclosed a copy of the Provisional Regional Energy Account for the month of January, 2016 (Page No-11/11) as above for further necessary action by the constituents.
