With reference to the above letters regarding preparation of regional energy accounting for Bhutan hydro stations, it is to inform you that Bhutan has net export of power at Indian border for the month of April-18.

The net energy exported from TALA & CHUKHA are calculated after adjusting the energy imported by Bhutan through 220kV system in the previous months i.e. Feb-18 & March-18.


Further the energy imported by Bhutan through 132kV Kurichhu system in Feb-18 & March-18 is being adjusted with the net Tala generation in the month of April-18. The remaining energy will be adjusted in the future Tala generation.

Please find enclosed a copy of the Provisional Regional Energy Account for the month of April-18 as above for further necessary action by the constituents.

Constituents are requested to intimate any discrepancy / error within two months from the date of issue of this provisional REA. In case of any discrepancy/error, the provisional REA would be revised based on re-examination, final decision and confirmation.
