
Please find enclosed a copy of the Provisional Regional Energy Account for the month of July'18 as above for further necessary action by the constituents.

The issue of reconciliation of accounts with Bhutan during the period from Feb-18 to April-18 was discussed in details in the 38th ERPC meeting held on 30.06.2018. As per the discussions taken in the meeting, a special meeting was convened on 13.07.18 among ERPC, ERLDC, PTC and Bhutan wherein the final reconciliation was done. The additional amount to be paid by the beneficiaries of Chukha HPS is given in **Annexure-I**. This amount may please be paid along with the energy bill for the month of July-18 for Bhutan Hydro stations.

Constituents are requested to intimate any discrepancy / error within two months from the date of issue of this provisional REA. In case of any discrepancy/error, the provisional REA would be revised based on re-examination, final decision and confirmation. In case no communication is received from any of the constituents indicating mistakes / discrepancy, the provisional REA as issued, would be treated as final.
