Upon receipt of meter reading data for the respective Hydro Stations from PTC, the REA for January' 19 in respect of Chukha HPS, Tala HPS & Kurichhu HPS is prepared.

During the month of January' 2019, the net energy import by Bhutan through 132 kV Kurichhu system was 15.366448 MU whereas the net energy export by Bhutan from Tala HEP was 1.459902 MU. The energy of 1.459902 MU from Tala HEP was adjusted with the energy imported by Bhutan through Kurichhu system. The remaining energy (13.906546 MU) will be adjusted in the future Tala HEP generation.

Please find enclosed a copy of the Provisional Regional Energy Account for the month of January'19 as above for further necessary action by the constituents.
