Please refer to the issuance of Provisional Regional Energy Account (REA) for the month of February' 19 issued vide this office on 05.03.19 excepting REA for Chukha HPS, Kurichhu HPS, Tala HPS (PageNo-12/12).

Upon receipt of meter reading data for the respective Hydro Stations from PTC, the REA for February' 19 in respect of Chukha HPS, Tala HPS & Kurichhu HPS is prepared.


The net energy import by Bhutan during February'19 through 132 kV Kurichhu system was 12.528768 MU whereas the net energy export by Bhutan during the month from Tala HEP was 4.642213 MU. The energy of 4.642213 MU from Tala HEP was adjusted with the energy imported by Bhutan through Kurichhu system. The remaining energy (7.886555 MU) for the month of February'19 will be adjusted in the future Tala HEP generation.

Please find enclosed a copy of the Provisional Regional Energy Account for the month of January'19 as above for further necessary action by the constituents.

Constituents are requested to intimate any discrepancy / error within two months from the date of issue of this provisional REA. In case of any discrepancy/error, the provisional REA would be revised based on re-examination, final decision and confirmation. In case no communication is received from any of the constituents indicating mistakes / discrepancy, the provisional REA as issued, would be treated as final.
