
The Cumulative energy import by Bhutan from January'19 to March'19 through 132 kV Kurichhu system was 37.982112 MU whereas the cumulative energy export by Bhutan for the same period from Tala HEP was 25.982457MU. The remaining energy 11.999655 MU has been adjusted in the current month Tala HEP generation.

Please find enclosed a copy of the Provisional Regional Energy Account for the month of April'19 as above for further necessary action by the constituents.
