<u>Subject</u>: Allocation of 2 MW power to Badarpur TPS from Talcher-I TPS out of share surrendered by DVC-reg.

Ministry of Power(MoP) vide their letter No. 3/1/2018-OM dated 06.11.2018 had allocated 2 MW power from Talcher-I TPS to Badarpur TPS on the request of NTPC for decommissioning activities and scrapping of Badarpur TPS. The said 2 MW allocation was from the 3 MW share proposed for surrender by DVC.

- 2. In this context, NTPC Limited was advised vide our letter No. 5/AI/CA/GM/2018/1755-63 dated 27.11.2018 to obtain intra-state open access from Delhi SLDC/STU and to approach CTU for facilitating the transfer of allocated power through ISTS. NTPC has accordingly obtained No Objection Certificate (NOC) from Delhi Transco Ltd.(DTL) and BPTA has been signed between DTL and NTPC Ltd., Badarpur TPS w.e.f. 01.06.2019 to 31.05.2020. Further, Badarpur TPS has been registered with Delhi State Load Despatch Centre SLDC) as Long Term Open Access (LTOA) Consumer. Also, NTPC Ltd. has opened Letter of Credit(LC) as per the requirement of CTU (POWERGRID) for 2 MW deemed LTA granted from Talcher-I TPS in Odisha-ER to Badarpur TPS in Delhi-NR-I.
- 3. In view of the above, 2 MW power from the 3 MW share proposed for surrender by DVC in Talcher-I TPS, stands allocated to Badarpur TPS (of NTPC Ltd.) for its decommissioning activities and scrapping of generating units. The said allocation will be in force upto 31.05.2020 i.e, the date upto which BPTA between DTL and NTPC Ltd., Badarpur TPS is in force. This allocation would be further subject to the maximum demand of Badarpur TPS remaining above 1 MW.

It would be pertinent to mention that as per the Electricity Act,2003, open access is allowable to a consumer whose maximum demand at any time exceeds 1 MW. Therefore, NTPC Ltd., is advised to intimate Ministry of Power/ CEA within a week of maximum demand of Badarpur TPS falling below 1 MW, for review of the matter. Moreover, Badarpur TPS will have to make alternative arrangements to meet its requirement as a regular consumer of the concerned DISCOM when its maxium demand falls below 1 MW.

Subject: Allocation of 2 MW power to Badarpur TPS from Talcher-I TPS surrendered by DVC -reg.

Sir.

Keeping in view the request from NTPC for allocation of 2 MW power for its decommissioning activities and scrapping of Badarpur TPS, it has been decided to allocate 2 MW from Talcher-I TPS out of 3 MW share proposed for surrender by DVC in this station.

- 2. This allocation will be for initial period of one year and would be reviewed based on the requirement of power for further decommissioning activities as per request of NTPC.
- 3. Badarpur TPS of NTPC is required to maintain LC commensurate with the allocated power.
- 4. CEA is requested to formulate principles for allocation of power for decommissioning activities for power plants in future. Draft proposal may be sent to this Ministry at the earliest.
