
With reference to the above,

1. ERPC vide letter dated 12.03.2022 had issued re-allocation of power to Gujrat from the power surrendered by Odisha from Barh-I w.e.f 00:00 hrs. of 13.03.2022 up to 23.59 hrs of 30.06.2022. **In line with this, the un-allocated quantum of power of Odisha has been allocated to Gujrat w.e.f 00.00 hrs of 10.04.2022 upto the period of firm share allocation.**
2. ERPC vide letter dated 26.03.2022 had issued re-allocation of power to Gujrat from the power surrendered by Rajasthan, Jharkhand and Sikkim from FSTPP-I&II, FSTPP-III, NPGCL w.e.f 00:00 hrs. of 27.03.2022 up to 5 years. **In line with this, the un-allocated quantum of power of Jharkhand and Sikkim from FSTPP-III & NPGCL has been allocated to Gujrat w.e.f 00.00 hrs of 10.04.2022 up to the period of their firm share allocation.**

3. ERPC vide letter dated 29.03.2022 had issued re-allocation of power to Tamil Nadu from the power surrendered by Jharkhand, Sikkim, DVC, Odisha and West Bengal from Barh-I, Barh-II and KBUNL-II(Subsidiary) w.e.f 00:00 hrs. of 30.03.2022 up to 5 years. **In line with this, the un-allocated quantum of power has been allocated to Tamilnadu from the share of Jharkhand, Sikkim, Odisha and West Bengal from Barh-I, Barh-II & KBUNL-II (Subsidiary) w.e.f 00.00 hrs of 10.04.2022 up to the period of their firm share allocation.**
4. **The percentage figures for scheduling of FSTPP-III, NPGCL, Barh-I, Barh-II & KBUNL-II (Subsidiary) upon re-allocation of un-allocated share of power to Tamil Nadu & Gujrat are provided at Annexure-A. The same shall be implemented w.e.f. 00.00 hrs of 10.04.2022.**
5. **The above re-allocations of un-allocated share have been done as pe CERC (Terms and Condition of Tariff) Regulation'2019.**
6. The beneficiaries are required to sign/extend PPA and enter into commercial arrangements/maintain LC with the allocated power.
7. This is based on the availability of ATC.
