**Statement of Revised Deviation charges for the week has been prepared as per CERC (DSM & Related matters) Regulation, 2022 implemented w.e.f. 05.12.2022 and Hon'ble CERC Suo Motu direction in Petition No.16/SM/2022, 01//SM/2023 & 05/SM/2023 implemented w.e.f. 28.12.2022, 08.02.2023 & 10.04.2023 respectively.**

सप्ताह के लिए विचलन शुल्क का विवरण सीईआरसी (डीएसएम और संबंधित मामले) विनियमन, 2022 के अनुसार तैयार किया गया है। 05.12.2022 और माननीय सीईआरसी स्वप्रेरणा से याचिका संख्या 16/एसएम/2022, 01//एसएम/2023 और 05/एसएम/2023 में निर्देश लागू किए गए हैं w.e.f. 28.12.2022, 08.02.2023 और 10.04.2023 क्रमशः।

The DSM for the week has been revised due to: (i) Revised outage of GMR on 08.01.2024 received from ERLDC on 08.02.2024, (ii) IBEUL account has not been calculated/deleted as per decision in Special Meeting on 19.02.2024.

सप्ताह के लिए डीएसएम को निम्नलिखित के कारण संशोधित किया गया है: (i) 08.01.2024 को जीएमआर का संशोधित आउटेज 08.02.2024 को ईआरएलडीसी से प्राप्त हुआ, (ii) 19.02.2024 को विशेष बैठक में निर्णय के अनुसार आईबीईयूएल खाते की गणना/हटाया नहीं गया है।

The constituents, who have to pay the Deviation Charges as indicated in the statement, are requested to make the payment to the Deviation and Ancillary Service Pool account operated by ERLDC within 07 days of the billing date. In case of delayed payments for Deviation charges against these bills beyond 07 days, the defaulting constituents shall have to pay simple interest @0.04 % for each day of delay.

- vi) Infirm Generator: OI DSM is Zero when Sch=0, DSM@general Seller, when sch is not zero.
- vii) Deviation Charge in respect of OD/UI or OI/UD of Cross Border Power transactions are as per seller (of respective category) or to a buyer (other than an RE-rich State), as the case may be.
- viii) Deviation Charge in respect of OD/UI or OI/UD of Inter Regional Power transactions are payable/Receivable at Normal Rate of charges for Deviation.
- ix) Beneficiaries with injection schedule will be treated as Buyer.
- x) Generating Stations with drawl schedule will be treated as Generating Seller.
