Minutes of the Special Joint TCC & ERPC Meeting held on 11.08.2025 through Online mode

CMD WBSEDCL & Chairperson, ERPC chaired the meeting.

MS, ERPC welcomed all the participants of the special joint TCC & ERPC meetings held on 11.08.2025 through online platform. The agenda of the meeting was forwarded by CTU on 30th July 2025 for deliberation in ERPC forum at the earliest, accordingly a CCM was convened on 05.08.2025. He briefed the details of the scheme in connection with the agenda point - "WR-ER Inter-Regional Network Expansion Scheme Part-A." which is primarily to facilitate inflow of RE power from WR to ER and to facilitate connectivity of proposed generating stations of APL at Raigarh area of Chattisgarh. He requested all states to provide their observations on the scheme.

Representatives of West Bengal, Odisha, Bihar and Jharkhand gave their concurrence to the proposed scheme. No representative of Sikkim was available in the meeting. On enquiry from WBSEDCL, CTU clarified that HTLS reconductoring from LILO point to new PPSP is not a part of the proposed scheme and shall be considered as a separate scheme (Part-B) with matching timeframe. Since the proposed scheme is likely to be implemented through TBCB route the reconductoring of existing line might be taken up by existing transmission licensee, however, cost sharing shall be done on user based of AC component incompliance with the extant CERC Sharing of Transmission Charges & Losses Regulation.

On query from Bihar on financial implication on the state after implementation of the scheme it was clarified that the additional cost shall be levied on user based as per present cost sharing mechanism.

MS, ERPC pointed out that there are many existing inter-regional transmission lines in ER-WR which are presently under-utilised. As an example, one circuit of 765 kV D/C Raipur-Jharsuguda line remained out most of the times for voltage regulation. Two 765 kV D/C Dharamjaygarh – Jharsuguda line is also lightly loaded at present. He suggested that CTU should explore options for better utilisation of these lines. CTU agreed to look into the issue. He also pointed out that present transmission capacity between ER and WR is around 25000 MW whereas presently, around 6000-7000 MW is being transmitted. It is observed that considerable amount of power from WR to NR is wheeled through ER. He opined that suitable transmission schemes may be planned for transmission of power through shortest route to minimize Transmission loss and associated cost. He further suggested that downward transmission of power beyond Jamshedpur towards load centres in West Bengal may also be planned as and when required by WBSETCL.

As no further views on the proposed scheme was received from any of the members, the scheme was accepted and recommended by ERPC to NCT.

Meeting ended with a vote of thanks to the Chair.
