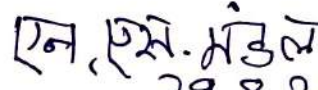
Sir/महोदय,

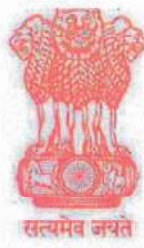

The aforesaid allocation will be operative for pro-rata distribution to the quantum of electricity mentioned above alongwith distribution of unallocated power from the declared capacity of the generating station based on auxiliary consumption, planned outage, and forced outage, availability of fuel / water etc. and after taking into account transmission losses.
3. The above allocation will further be subject to the Power Purchase Agreements (PPAs) entered into by NTPC Limited with State Power Utilities of Eastern Region and will further be subject to the beneficiaries ensuring compliance with the financial and commercial terms (including coverage for Letter of Credit) of the PPA signed with NTPC Ltd., the tariff notification and any other directives/ guidelines issued by the Government of India /Central Electricity Regulatory Commission from time to time.

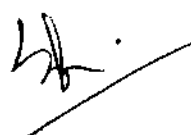

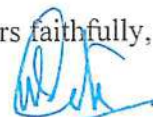
